In the event that your application is accepted, processed and approved following your initial screening, you will be provided a conditional offer of housing as explained in the accompanying FCHA Disclosure Statement.

In the event a final offer of housing is thereafter extended, you will need to provide a deposit equal to one months rent in the form of a cashier's check or money order, made payable to Tower Management Service, LP. The security deposit of 1 months rent, can be paid with a cashier's check or money order, and brought in at the time of your lease signing.
