PERMITTED PETS: Pets, including dogs and cats are permitted at the community with the Landlord's written approval and the complete execution of a Pet Application and Pet Addendum.

Certain breeds of dogs will not be permitted at the community. These include but are not limited to: Pit Bulls, Tosa Inus, German shepherd, Rottweiler, Presa Canarios, Akitas, Argentine Dogos, Fila Brasileros, Chow Chows, Shar Peis, Dalmatians and Doberman Pinschers. Landlord may reject any pets for any reason Landlord deems appropriate.

Certain other pets are not permitted. These include, but are not limited to: *Monkeys, Ferrets and Snakes*.

Certain other pets may be accepted under a separate written agreement with Landlord, these are: Birds & Fish (fish tanks must not exceed 30 gallons).

- 1. All pet owners must complete a Pet Application and include the following information:
 - a. Photo of pet
- b. Veterinary records
- 2. Once the Pet is approved for occupancy, the following documentation & fees must be provided:
 - a. One time non-refundable fee of \$500.00 for dogs and \$300.00 for cats
 - b. Renter's Certificate of Insurance acknowledging Landlord as Additional Insured and or Additional Interest and listing a liability amount of \$500,000 for dogs.
 - c. Municipal Registration (for dogs)
- 3. Pet owner is required to sign a Pet Addendum, and will be responsible to pay an on-going monthly pet rent of \$25.00 per dog / \$25.00 per cat.
- 4. Each year at Lease Renewal your pet information will need to be updated and returned to the Management Office and/or Landlord.
